## 5. SCIENCE AND WATERSHED ENHANCEMENT

- 5:1 SWAMP update (see attached): P.M reports are forwarded to Board as they come available. Twenty people participated in the Volunteer Wetland Trainings. Most of the Technician and P.M. hours are used. Amphibian and plant specialists will visit unique wetlands Aug. Jennifer Yeow will direct benthic sampling, Aug.-Sept. 5:2 Water Studies: N/A
- 5:3 Carpenter Creek Project: Gary Parkstrom has taken the lead and has been communicating with interested parties. Lee Hesketh is due back in the area this fall and is eager to start designing mediation for the damaged areas of the creek.
- 5:4 Invasive Species: CKIPC/FWCP Small Lakes Survey has started and will do Summit and Box Lakes Aug. 5-7<sup>th</sup>. Slocan Lake will be surveyed in Sept. 2<sup>nd</sup> -4<sup>th</sup>. Signs may be going in at Wilson Lakes.
